10th class students of the state.

Memo:-

This is to inform you that in compliance with the orders and subsequent approval of the Govt. of Himachal Pradesh, the Directorate of Hr. Education has entered into an agreement with the CBSE Delhi to get the above mentioned Career Aptitude Test (SGAI) conducted by them for the 10th class students of the Govt. schools of the H.P. tentatively in the 2nd/3rd week of April 2012. Exact date of this test will be notified later on after completing all formalities about this test. This test shall reflect the interest inherent capability, talent or ability and interest profile of the child and is aimed at empowering with self knowledge to enable in making informed subject choices. The different aspects of this test shall focus on Scientific Aptitude, Numerical Aptitude, Social Aptitude, Behavioral Science Aptitude, Art Aptitude and interest areas. In simplest words, this test will help the child assess his own inborn capabilities and take right decision about his post matric stream.

For this proposed test every interested student will have to pay Rs.100/- to the CBSE through the Head of the institution as fee and will have to submit his application on prescribed proforma for the purpose of registration. This fee is subject to increase/decrease marginally as per demand of the CBSE office calculation of exact expenditure to be incurred on no profit/no loss basis.

In view of this, you are hereby requested to motivate the students to participate in this self examining kind of test in the interest of their right decision for future and obtain written application on prescribed proforma from the interested ones for the purpose of registration alongwith the fees. The detailed information in tabulated form be sent to the Principal, SCERT Solan Distt. Solan alongwith the consolidated draft of money collected from students in the name of the Secretary, CBSE, Delhi (crossed) for further necessary action by **20th Dec. 2011 positively under intimation to the concerned Dy. Dir. of Hr. Education and undersigned**, so that CBSE can be requested accordingly to conduct the test.

Separate fee receipt for CBSE Test be issued to the students maintaining proper record for the purpose of any audit/inspection etc. in future.

There must be no delay regarding the date as given above, because it is a time bound programme & defaulters, if any, will be responsible for the consequences.
