OFFICE ORDER

In continuation to this Directorate office order Even No. dated 25.06.2009, on the recommendations of the Departmental Promotion Committee the following in-service TGTs possessing the Master Degree in the different subjects are hereby **promoted as Lecturer (School-Cadre)** in the respective subjects, **on regular basis** in the pay scale of Rs. 6400-10640 **on notional basis w.e.f. 16-7-2008** and posted in Govt. Sr. Sec. Schools as shown against their names **subject to the conditions that no complaint /inquiry/vigilance case and disciplinary proceedings are pending against the individual concerned.**

He/She should report for duty to the concerned Principal within stipulated period .The concerned Principal/Headmaster will relieve the promoted TGTs immediately. The salary of the promoted Lecturers for the next month will be drawn from the school of his /her posting .If the promoted lecturer is not willing to avail the promotion though he/she has no right to forgo the promotion in public interest, the **concerned Principal will take the option of non availing the promotion from the concerned lecturer** .The copy of the same will be pasted in his/her service book and the other copies be sent to this Directorate and Dy. Director concerned invariably for further action .The promote Lecturer will join their new place of posting on or before **03-10-2009** positively failing which promotion orders as Lecturer (School-Cadre) shall deemed to be withdrawn automatically **for one year or next DPC whichever is later** .No specific orders with reference to withdrawal of promotion orders will be issued separately. **No extension will be available in any case for joining.**

The financial benefits will be admissible from the date of joining the post of Lecturers. He/She will be entitled TA/DA and joining time as admissible under the Rules. Official who want to get their pay fixed according to the option, he/she will have to exercise their option within one month from the date of promotion.

1. These promotions will however be subject to the final outcome of the W.P (Civil) No.61/2002 titled Sh. Nag Raj and Ors Vs Union of India and Ors. and W.P.295/2002 titled Devi Ram Tanwar and Ors Vs Union of India and Ors. in the Hon'ble Supreme Court of India or any other decision taken /order issued by the State Govt. of the subject from time to time.
2. If the above Promote has been transferred to other institution, the concerned Principal/Headmaster will ensure to send the promotion orders to the school where he/she has been transferred and report thereof be sent to this Directorate immediately.
3. Those who have been posted outside the sub cadre /Tribal area will have to serve in difficult sub cadre area as and when the vacancy occurs in Tribal/Sub cadre Area.
4. The lecturers who have been promoted in the subject Science / Commerce may be allowed to join only if the Science / Commerce classes are running in the school concerned.

Necessary intimation to this effect is furnished to this Directorate as well as to the institution where he/she is posted.** It will be the sole responsibility of the concerned Principal/Headmaster to ensure availability of option not to join / relieving orders within a week's time after the stipulated period to this Directorate as well as concerned D.D.E.

Principal of the concerned school is requested to **scrutinize the academic/professional and SC/ST certificates of the individual concerned at the time of joining and joining report be sent to this Directorate immediately.** In case the concerned promote does not report for duty in the school with in the stipulated period, the matter may be reported so that next in panel could be promoted. They will ensure that the instructions issued on the subject are strictly adhered to in letter and spirit and for any departure, they will be held responsible. The above Principal will ensure the submission of joining/Non joining report within a week's time after the expiry of the stipulated period.
